  - (b) The customs department of a European country has rejected goods exported into the country on account of deficiencies in their packaging. Outline the aspects of the packages that may account for the rejection of goods. (10 marks)
- 5. (a) Miss Fikira who was recently hired by Muvuko enterprises has been tasked to implement the operational distribution plan for the organization. Outline the activities she is expected to undertake when implementing the plan. (12 marks)
  - (b) The crane is one of the equipment that a distribution firm may use to handle goods.
