- 1. (a) Explain six ways in which law has enhanced the tourism sector in Kenya. (12 marks)
 - (b) Explain four types of jurisdiction of the Kenyan courts. (8 marks)
- 2. (a) In a football match, a goalkeeper was hit in the eye from a ball thrown by an opponent. The goal keeper demanded that the opponent raise money for his medical costs but the opponent declined. The goal keeper intends to take a legal action. Explain the legal principles applicable in this case. (8 marks)
 - (b) Explain six ways in which a contract may be discharged. (12 marks)
- 3. (a) Explain the provisions for protection of children, under the employment law in Kenya. (12 marks)
 - (b) Daniel insured his tourist lodge against fire with Bele Insurance Company. The proposal form had required Daniel to state whether the lodge had earlier been insured against fire. Daniel completed the proposal form but did not state that the lodge had earlier been insured against fire since the cover had come to an end.

 Four months later, the lodge was completely damaged by fire. Daniel has sought compensation from Bele Insurance Company. However, the insurance company refused to compensate him, claiming that he lied not to have insured the lodge at any given time. Daniel is aggrieved and intends to enforce compensation in a court of law.

 Explain the legal principles applicable in this case. (8 marks)
- 4. (a) Outline **five** functions of the Tourism Regulatory Authority. (10 marks
 - (b) (i) In the event of an unjustified termination of employment contract, the court may order compensation to the affected employee. Outline **three** such forms of compensation. (6 marks)
 - (ii) Highlight **two** forms of reinstatement of an employee whose termination of employment contract is found to be unjustified. (4 marks)
- Under the Narcotic Drugs and Psychotropic Substances Act (2012), the Director of Public Prosecutions may seek international assistance for the purposes of an investigation or proceedings. Describe the procedure followed in seeking such assistance. (12 marks)
